#### New survey looks at impact of court delays on victims

The Victims' Commissioner, Baroness Newlove, has launched a new survey exploring the impact court waiting times have on victims across England and Wales and the services in place to support them.

Amid lengthy delays throughout the criminal justice system – from police investigations to court proceedings, including the Crown Court backlog – it's important for the Victims' Commissioner to hear from victims about the impact these are having on their experiences of the criminal justice system.

#### New Powers for Judges makes early engagement with medication vital

The changes, which came into force in April, will mean families going through court could see higher costs and longer proceedings if they don't engage in alternative dispute resolution.

**ONE** of the UK's leading relationships charities, **TLC**: **Talk**, **Listen**, **Change**, has urged families considering court proceedings to engage with mediation services early in the process following recent changes to the Procedure Rules.

These new changes mean judges can now promote non-court dispute resolution without needing agreement from the parties, potentially adjourning hearings which can lead to additional costs and delays, as well as requiring a new form to be submitted explaining why non-court dispute resolution has not been attempted or has failed.

Since 2011, individuals have been required to attend at least a Mediation Information and Assessment Meeting, known as a MIAM, before filing a court application, with certain exemptions. These meetings involve a consultation between an individual and a Mediator to discuss why mediation could benefit the parties in the negotiation process.

The new raft of powers available to judges are set to radically shake up these processes in which mediation is involved, and are aimed at reducing the number of decisions that proceed to a court ruling.

As well as adjourning proceedings, judges can also order individuals to pay the other party's costs if they deem their refusal to try non-court dispute resolution unreasonable.

Following these developments, experts at Talk, Listen, Change have warned parties going through court that they should try to engage with the mediation process early in order to save significant costs further down the line.


Participants involved in mediation can also get financial assistance for the process. In March 2021, the Government Voucher Scheme was launched, providing £500 towards joint mediation sessions for separated families discussing child-related issues.



#### Safe Lives – Specialist Training for Professionals

**Non-fatal strangulation (NFS)** is used by perpetrators of domestic abuse to control and intimidate their victim. It is an insidious and lethal form of physical violence which recently became a standalone criminal offence in the Domestic Abuse Act 2021. Despite the strong link between NFS and domestic homicide, it can be difficult to evidence due to a lack of visible injury.

- 20,000 women in the UK experience non-fatal strangulation every year
- 32% of Independent Domestic Violence Advisor (IDVA) caseloads involve a client who has experienced NFS
- Between July 2022 and June 2023, around **700** offenders were sentenced for non-fatal strangulation or suffocation offenses, with an increase in each quarter since the offense was introduced

We're thrilled to have worked with the Institute for Addressing Strangulation to develop and deliver specialist training for professionals who encounter victims and survivors of NFS.

#### Preventing sexual harassment in the workplace' - The Change Project

From October 2024, the Worker Protection Act comes into effect. Workplaces will have new legal duties to ensure they take reasonable steps to prevent sexual harassment in the workplace.

The Change Project is providing 'preventing sexual harassment in the workplace' training for all workplaces. The training is tailored to the individual needs of the organisation. The Change Project will meet with organisations for a consultation and assessment prior to conducting the training.


HSAB and HSCP have published their Training and Resources offer for 2024.

#### **FUNDING & COLLABORATION**

#### **Grants for Drop-In Hubs to Help Young People with their Mental Health (UK)**

The **Prudence Trust** is making £1.5 million in funding available to support drop-in hubs that offer mental health interventions to young people aged 11-25 across the UK. The funding aims to support young people's early support hubs in maintaining existing services, strengthening relationships with clinical partners, or adding new services. The opportunity is open to UK-registered charities or CICs with an annual income of over £1 million and at least three years of experience delivering a drop-in hub. The Trust anticipates awarding **3 to 4 grants of between £250,000 to £500,000** each for up to 24 months. Eligible costs include salaries, evaluation work, and training. The deadline for first-stage applications is 2pm on the **9th of September 2024**.
